#### **Information About Voices From Care**

Voices From Care is an organisation for children and young people who are or have been looked after in Wales. Voices From Care is unique in that it is run by people who have experienced the care system themselves.

Voices From Care was set up in 1993 after children and young people in England and Wales began to ask questions about how the looked after system was being run. Voices From Care's mission is to bring children and young people together throughout Wales, who are, or have been looked after by local authorities, voluntary and private organisations, in order to: 1) provide opportunities, 2) improve conditions, 3) promote the voice of children and young people, 4) protect their interests.

Voices From Care is a user - led organisation, and a number of the staff team have experienced the care system. A number of young people are heavily involved in our work, either as volunteers or board members. Volunteers assist in the work of the organisation, particularly in the delivery of training and in consultation work. The work areas include: membership, advice and support work service, the training service, research, consultation and campaigning



# **Consultation Response**

#### **Introductory Points**

Voices From Care welcomes this opportunity to respond the consultation on the Social Services (Wales) Bill. As a general point the organisation would like the name of the Bill to be amended to the Social Care and Well-Being Bill to reflect the role of all the partner agencies who need to be involved in the delivery of the Bill, if it is to deliver its objectives.

Whilst Voices From Care welcomes the broad principles of the consultation document we have some caution in that the document does not give enough detail on the vision of the Welsh Government and on what the proposed changes would look like for citizens who are users of services. Whilst we welcome the principles underlining the Bill, Voices From Care is not certain that the changes proposed will necessarily result in those principles becoming a reality. It will be the detail of Bill and subsequent regulation and guidance which will start to give us an idea if these principles are really achievable.

The document does not inform us about whether and how the Bill will build on existing legislation. The Bill will need to demonstrate clarity about how it will build on existing rights and mechanisms for participation, and also demonstrate that there are adequate government and statutory structures to deliver the principles of the Bill. Without knowing this detail and having these reassurances, Voices From Care retains a position of caution in relation to the Bill.

Voices From Care would like the document to be stronger in its reference to the United Nations Convention on the Rights of the Child (UNCRC) as well as its referencing to human rights. The organisation would like to see the principles of the document set in a rights framework and the empowerment this offers, rather than in a needs framework. We believe this would be more in line with the vision of the Bill.

Voices From Care has some concerns that in the document and its proposals the rights, developmental needs and voices of children and young people may be lost in relation to the people in need agenda. We feel it is essential that the Bill safeguards the position and interests of children and young people. The organisation has further concerns that children and young people looked after and leaving care may become a further marginalised and voiceless group, particularly in relation to the setting of services for children in a family context. The unique position of children living away from their families needs

particular attention.



Voices From Care is also concerned that those who lobby for the rights of children and young people will also have their influence reduced against the various adult representative groups in regard to the people in need framework.

Voices From Care feels that the document is weak on the explicit promotion of participation mechanisms and advocacy services, and that these should be strengthened within the Bill, particularly if the principle of a strong voice and control is to be achieved

Voices From Care would like further clarity on how the principles, which are very adult focused, relate to children and young people – particularly those of a stronger voice and control.

Voices From Care would see that although the Bill may achieve savings in the long-term, the implementation of the Bill will require extra funding and resources in its implementation.

#### 1. Maintaining and enhancing the wellbeing of people in need

#### 1.1 Wellbeing of people in need

**Question 1 -** Do you agree with our proposals to base this legislation on the concept of maintaining and enhancing the wellbeing of people in need?

Voices From Care welcomes this proposal to base this legislation on the concept of maintaining and enhancing the wellbeing of people. We felt that this concept would give an essential benchmark enabling people to monitor their well-being and to gauge if they may be eligible for services. However we would like to see the proposal set out in a rights based framework as opposed to a needs based framework. The concept of maintaining and enhancing the well being of people in need to must take account of the particular rights, developmental needs and societal position of children and young people.

**Question 2** – Do you agree with our working definitions of "wellbeing" and "people in need"? Do you wish to suggest alternatives?

In general Voices From Care agreed with the definitions - the organisation feels that there may be further



work needed to ensure that the definitions cover the issues which children and young people face.

**Question 3 –** What are your views on the proposed general duty on local authorities and their partners to maintain and enhance the wellbeing of people in need in their local areas?

Voices From Care is very supportive of this duty

**Question 4** – What are your views on the proposals to provide guidance on this area through the Code of Practice?

Voices From Care welcomes this proposal.

Voices From Care welcomes this proposal.

Voices From Care welcomes the proposed definition of 'social care services' as this will assist people seeking and using services



# 2. A stronger voice and real control

#### 2.1 Information, advice and assistance

**Question 7 -** Do you agree that we need to make a significant step forward in making information, advice and assistance accessible?

Yes

Voices From Care that there should be some direction given, but that there is a need for discretion at a local level to fit the needs of the local population.

# 2.2 Assessment of need



# Question 10 - Do you agree there should be a single right of assessment?

Yes, however it must be able to cover the particular developmental needs of children and young people and their particular circumstances and position in society.

**Question 11 -** Do you agree the new system will benefit service users and their carers, as well as professionals in understanding their duties of assessment? If not, why?

Yes

**Question 12 -** Do you agree that law and policy should provide for proportionate assessments i.e. a formal prescribed assessment for people who have social care needs?

Yes, but there will need to be clarity on who decides what is proportionate and the mechanisms for this. Access to advocacy services will be important at this point.

**Question 13 -** Is it helpful to prescribe the assessment process and who should be involved?

To some extent, but this should not be overly prescriptive.

**Question 16 -** Do you see a role for self assessment and if so, how would this work?

Voices From Care is supportive of the principle of self assessment, although there must be support available to enable people to achieve this.

# 2.3 Portability of assessments



**Question 17 –** Should the Bill impose a general duty on local authorities and their partners to provide social care services to a person in need who resides in their area?

Yes

**Question 18 -** Do you agree that portability of assessment will bring greater consistency of care for services users? Do you agree that it will lead to savings?

Yes Voices From Care agrees that portability of assessment will bring greater consistency of care for services users. We agree that it will lead to savings in the long term once systems are well established, although in the short term there may be a need for extra resources.

**Question 19 -** When someone moves into a new local authority area, what do you think is an acceptable period for which to require that the new authority must maintain the assessment of a service user before it reviews the case?

3 months

Question 20 - Do you agree with our proposals for notification and transfer of information?

This will require robust mechanisms.

\*\* Voices From Care notes that looked after children would be excluded from these arrangements for portability – however there may be some need to consider their position particularly in respect of health and education. The position of care leavers will also need clarity. Voices From Care is concerned that these groups have equality in regard to the issue of consistency in services if they move area.

#### 2.4 Management and review of care plans

**Question 21 -** Do you agree that the statutory duty changes we have outlined above are the right ones to improve care and support plan and review systems?

Yes

Yes, although being too prescriptive may not be helpful.

#### 2.5 National eligibility framework

Question 23 - Do you think that a new national eligibility framework will be beneficial?

Yes, but Voices From Care is concerned about how people being assessed for services would contribute to this on as an individual and how citizens on a collective level would contribute.

**Question 24 -** What do you see as the local authority's role in setting criteria for eligibility and what do you see as the Welsh Government's responsibilities?

**Question 25 –** Do you believe that the current four-level definition of eligibility: "critical, substantial, moderate and low" is a helpful way of categorising eligible needs?

Voices From Care is concerned about how the voices of individual citizens would be heard, and that some people may be denied access to services, although we accept the need for some categorisation.

**Question 26 -** Do you agree the new framework should extend to all categories of people in need - both children and adults?

It is concerning that the document suggests that children with what may be categorised as a low level social care need may not receive a service. Voices From Care would like to see more detail on the impact of the proposal for a national eligibility framework and what this might mean for children and young people.

**Question 27 -** Do you envisage any particular barriers in operating a single eligibility threshold? How would you overcome these barriers?

**Question 28 -** Should people be able to self assess for access to services? If so, how would you see this working?



Yes but information and support will need to be available to facilitate this.

Voices From Care does not generally believe that foster carers should be able entitled to a carer's assessment. This is because there should be other mechanisms for support. Allowing local authority's discretion may lead to inconsistencies across Wales.

However we do see that there may be a case for kinship carers (family and friends) being able to request an assessment or in very particular circumstances where a child has complex needs and is in a long term placement.

Voices From Care would like to see a range of methods used to achieve service user representation. It may be that links to regional service user representative bodies such as junior safeguarding boards are the best ways to achieve service user input. Voices From Care would be disappointed to see the progress in the representation of services users through such mechanisms as junior safeguarding boards lost.

Voices From Care welcomes this consultation in regard to adult protection, although we are cautious and feel that the implications, particularly for young adults need to be carefully thought through. The organisation would like to see a legal framework that is supportive and not punitive or oppressive, and a framework that promotes appropriate intervention and quality services. We feel that the details of the implementation of framework for adult protection will be crucial. We are concerned about over intervention. Some level of risk is necessary for young adults to develop. We welcome this agenda as an opportunity for progress on issues such as sexual exploitation and trafficking. We also welcome this as an opportunity to raise issues of protection for young people, who are often lost in the gap between services for children and adults.

#### 6. Services



#### 6.1 Adoption

Voices From Care supports the proposal for the setting up of a National Adoption Service. We feel the exact functions require further debate.

**Question 91 -** Do you have any other comments that you wish to make about our proposals for a National Adoption Service?

Voices From Care welcomes the role a National Adoption Agency could have in highlighting and alleviating some of the inconsistencies in adoption services around Wales and in the experiences of children. We feel it could be a central point for all those involved and affected by adoption. It could champion children's rights. Voices From care feels that money needs to be ring fenced to improve adoption services. We feel the control and management of a National Adoption Service should be separate from the local authorities, although there will need to be clear lines of communication with local authorities. Within its remit the National Adoption Service should also understand and raise awareness of the other routes to permanence for children and young people, and have an overarching concern about the whole looked after experience. Voices From Care feels that the National Adoption Agency and its work / influence should be grounded in an evidence base of what works for children and young people looked after.

# 6.2 Transitions for disabled children and young people

**Question 92 -** Are there any key, identifiable entitlements that disabled children receive that would be of continued benefit beyond age 18 for those with the most complex needs? Please provide details and rationale.

Voices From Care would welcome more detail on this proposal. Disabled care leavers who are moving from children's to adult services are currently receiving an inconsistent service. We welcome the proposal to make this transition smoother. We do not necessarily agree with the explanation for this proposal. The experience of Voices From Care is that adult services often have the most appropriate resources for disabled care leavers post 18. However it is often the lack of communication and good working relationships which can make the transition difficult.
